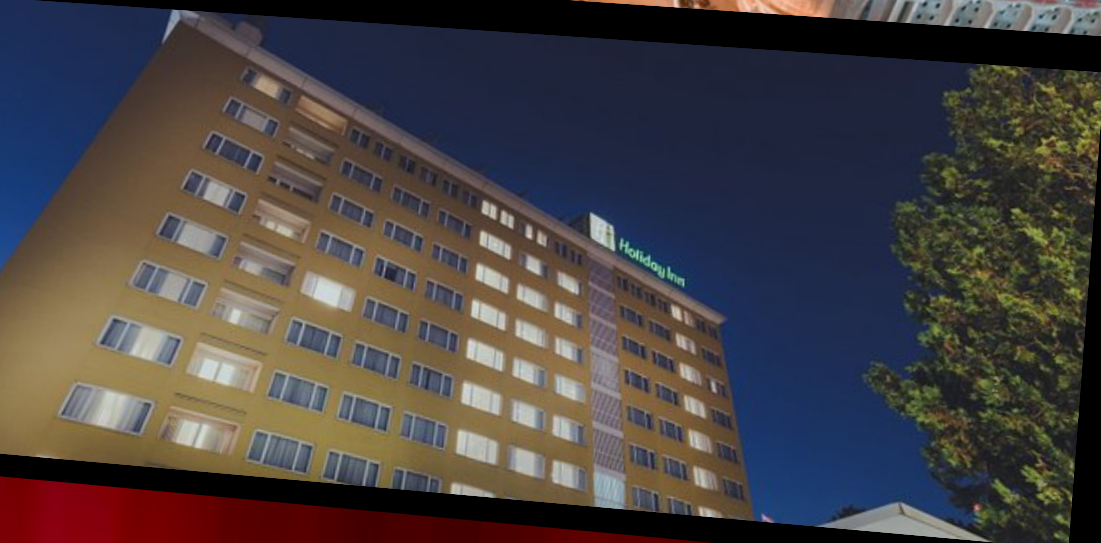

Abstract guidelines

Abstract Guidelines for Medical Case Report:

1. Title:

- Choose a concise and descriptive title that reflects the essence of the case.

2. Authors:

- Include the names and affiliations of all contributing authors.

3. Case Presentation:

- Provide a succinct overview of the patient's history, clinical findings, and relevant diagnostic results.
- Treatment approach taken and the patient's response.
- Include any follow-up information and outcomes.

4. Keywords:

- Include a few keywords that highlight the main aspects of the case.

- Abstracts must not exceed 300 words (excluding title, authors, and institution) and should be written in English.
- Verify your abstract for typographical errors, especially in your name, surname, and title. This information will be used for certificate creation.
- Include the institution where your work is conducted and list all coauthors. The first author's full name should be in all capital letters, while coauthors and the mentor should be in lowercase letters with the first capital letter.
- Avoid including tables, charts, or pictures in your abstract.
- Once submitted, you cannot modify your abstract.
- Use Times New Roman font, size 11pt, and single line spacing for the abstract text.
- The title should not be in all capital letters; it should be in bold.
- You can be the presenting author for only one abstract, but you can be a co-author on several abstracts.
- Abstracts not meeting these criteria will not be accepted.

Presentation Guidelines for Medical Case Report:

Presentation Guidelines for a 10-Minute PowerPoint Presentation:

1. Slide 1: Title Slide
 - Title of the case report, authors, and affiliations.
2. Slide 2: Introduction
 - Briefly introduce the patient and the purpose of the case report.
3. Slides 3-4: Case Presentation
 - Provide concise information on the patient's history, clinical findings, and diagnostic results.
4. Slide 5: Diagnosis
 - Clearly state the diagnosis and differential diagnoses.
5. Slides 6-7: Treatment and Outcome
 - Highlight the treatment approach, patient response, and outcomes.
6. Slide 8: Discussion
 - Discuss the unique or educational aspects of the case.
 - Relate the case to relevant literature.
7. Slide 9: Conclusion
 - Summarize key findings and the significance of the case.
8. Slide 10: Q&A
 - Open the floor for questions from the audience.

Presentation Tips:

- Stay Concise: Stick to essential information and avoid unnecessary details.
- Use Visuals: Include images, graphs, or charts to enhance understanding.
- Practice Timing: Ensure your presentation fits within the 10-minute timeframe.
- Engage the Audience: Encourage questions and interaction during the Q&A session.
- Professional Appearance: Use a clean and professional design for your PowerPoint slides.

Remember, the goal is to convey the key points of the case report clearly and engage the audience within the given time limit.
